GENERAL INFORMATION

RIZEN™ 7-28-3 is Fertilzona's basic NPK starter fertilizer formula. It is formulated with a pH of slightly below 5 limiting the possibility of free ammonia damage to seedlings.

This high Phosphorus, 2:1 ratio of Nitrogen to Potassium SmartBlend™, is compatible with most minor elements and nutrient enhancers. RIZEN™ 7-28-3 is non-phototoxic and can be mixed with imidacloprid and most other pesticides and fertilizers, but jar testing is recommended.

RIZEN™ 7-28-3, injected 2–3 inches below the seed line at planting will give a quicker and more vigorous start to young seedlings.

- Supplies seedlings with essential nutrients
- Buffers soil for improved uptake of nutrients
- pH of less than 5, but test final mix for correct pH and buffer if necessary

DIRECTIONS FOR USE

Row Crops: inject 10-20 gpa of RIZEN™ 7-28-3 2–3 inches below seed line at planting.

RIZEN™ 7-28-3 can be diluted with water for easier calibration.
