GENERAL INFORMATION

FERTI-BUFF 0-8-0 is an acidifier for use with agrichemicals. FERTI-BUFF 0-8-0 is especially useful for reducing hydrolytic breakdown of various pesticides, such as organophosphate insecticides, in alkaline solutions.

COMPATIBILITY

FERTI-BUFF 0-8-0 is compatible with phosphate carbamate and chlorinated hydrocarbon insecticides. Use care when combining with copper fungicides since this product may cause plant injury. DO NOT COMBINE WITH 2, 4-D, FORMULATION, as a precipitate may form and herbicidal activity be reduced. If any question of compatibility arises, a small test batch should be made prior to full batch mixing. NOTE: Bait products may be less effective when mixing with FERTI-BUFF 0-8-0.

DIRECTIONS FOR USE

CONSULT YOUR LOCAL FERTIZONA REPRESENTATIVE OR OTHER AGRICULTURAL SPECIALIST FOR SPECIFIC CROP RECOMMENDATIONS.

Read and follow the precautions, restrictions, and recommendations on the labels of pesticides used with FERTI-BUFF 0-8-0. Use according to the most restrictive label directions for each product in any tank mixture. COMPATIBILITY: FERTI-BUFF 0-8-0 is compatible with most pesticides. However, if the desired combination has not been previously used, a compatibility test is recommended.

MIXING: Fill spray tank ½ full of water and begin agitation. Add FERTI-BUFF 0-8-0 and mix thoroughly. Add pesticides as directed by label or in the following sequence: (1) Dry flowables or water dispersible granules, (2) Wettable powders, (3) Flowables, (4) Solutions, (5) Emulsifiable Concentrates. Continue agitation while completely filling spray tank.

RECOMMENDATIONS: Specific use rates will vary with conditions of application such as water hardness, application method, equipment, spray droplet size, condition of foliage, etc. Use enough FERTI-BUFF 0-8-0 to achieve the desired level of acidulation and buffering.

Use ½ to 2 qts. FERTI-BUFF 0-8-0 per 100 gallons to reduce the pH of alkaline waters for pesticide

DO NOT OVER-APPLY. Dosage rates or concentrations higher than suggested can cause slight burning of foliage of susceptible crops.

FIRST AID
