DIRECTIONS OF USE

1 to 2 Quarts per Acre. – **SHAKE WELL** –

FOLIAR APPLICATION RATES

All Crops: Irish Kelpful may be applied by air or ground. Apply 1- 2 quarts per acre.

SOIL APPLICATION RATES

Field & Row crops, Vegetable and Fruit crops: Apply 1-2 quarts per acre in a surface or sub surface band. Repeated applications at 10-14 days may be beneficial.

Orchard and Vineyards: Inject 1-2 quarts per acre 3 to 5 in. deep at the drip line, or surface band and water into the soil. Repeated applications at 10-14 days may be beneficial.

Transplant Water – All Crops: Apply 1 to 2 quarts in minimum of 100 gallons solutions.

- Application at planting can be in the seed furrow, T-banded, sprayed on seedbed, or as a bare root or transplant drench.

FERTIGATION APPLICATION RATES

Field & Row Crops, Orchards & Vineyards, Vegetable & Fruit Crops: Use 1-2 quarts per acre per irrigation. Continue irrigation for a minimum of 2 hours after application to flush lines and to maximize distribution of nutrients with drip and micro sprinkler use.

When applying in drip application, inject after irrigation filter.
